Patient Assistance Program

Under this program, Coherus BioSciences, Inc. agrees to ship product to the provider for patients who qualify for the Patient Assistance Program (PAP). The terms and conditions below must be met in order for a patient to be enrolled in the program:

- Uninsured, functionally underinsured or Medicare patients that demonstrate financial hardship and cannot afford their cost-sharing obligation
- Adjusted annual household income of \leq 500% of Federal Poverty Level (FPL)
- Patient must complete and sign the consent and, when applicable, provide income documentation
- The patient must be under the care of a U.S. licensed provider and receive the drug in an established practice located in the U.S. incident to the prescribing physician's professional services
- U.S. resident and must physically reside in the U.S. or U.S. territory
- The patient must receive the drug in the outpatient setting incident to the prescribing physician's professional services
- Diagnosis and dosing must be consistent with FDA-approved indication for UDENYCA® (pegfilgrastim-cbqv)
- Medicare insured patients are required to provide an attestation signed by their provider demonstrating financial hardship due to inability to afford cost share
- Providers, for insured patients I understand that the Coherus COMPLETE™ program does not provide free drug in the instance of an administrative error or a coverage restriction such as a step edit or others deemed as restrictions. For certain products where step edit may not be medically appropriate, and confirmed by the prescribing physician, the Coherus COMPLETE™ program may consider enrollment following one level of appeal.
- Providers requesting more than six (6) PAP fills for the same patient will be required to provide written attestation on business letterhead reaffirming continued PAP necessity (DX, patient therapy log, etc.)

I understand that the PAP provides UDENYCA® (pegfilgrastim-cbqv) at no charge and does not include the provider administration fee. I also understand that I am responsible for the administration costs.

I authorize the release of information about me and my medical condition, and I authorize my healthcare provider to release my protected health information and other individually identifiable information, including insurance and financial information, to Coherus BioSciences, Inc., its affiliates, its program administrators, and their respective agents, service providers and field reimbursement professionals (collectively, "Coherus") for the purpose of determining my eligibility for the PAP, and if I am eligible, enrolling me in the PAP, and for managing and administering the PAP program. I understand that once my protected health information is disclosed as permitted by this authorization, it may be redisclosed by Coherus and will no longer be protected by the Health Insurance Portability and Accountability Act of 1996 (HIPAA) or other federal privacy laws. I understand that I may refuse to sign this authorization. I may also withdraw/ revoke this authorization at any time in the future by contacting my healthcare provider or Coherus COMPLETE™ at 1-844-483-3692. My refusal or revocation will not affect the commencement or continuation of my treatment by my healthcare provider; however, if I do not sign or revoke this authorization, I will not be eligible to participate in PAP. If I revoke this authorization, my revocation will not affect protected health information previously disclosed in reliance upon this authorization. I understand and agree that this authorization will remain valid for five (5) years after the date of my signature, unless I revoke it earlier. I understand that I may receive a copy of this authorization.

By applying for PAP, I understand and agree that (i) there is no charge to participate and my participation is not contingent upon any requirement to purchase any Coherus product; (ii) completing and signing the PAP application and this authorization does not guarantee my eligibility; (iii) PAP may change or end at any time; (iv) PAP medication received will not count toward my true-out-of-pocket costs under Medicare Part D; and (v) I will not seek to be reimbursed or receive credit from any insurance provider, including Medicare Part D plans, for any PAP medication received. I can confirm that I do not have coverage for UDENYCA® or any other pegfilgrastim product (biosimilar or reference product).
